

TALKING POINTS & OUTLINE
Executive Order #13848 on Imposing Certain Sanctions
in the Event of Foreign Interference in a United States Election

- The October 30, 2020 (updated Nov 03rd) and October 22nd FBI/CISA alerts on Iranian interference triggered the authorities vested in the President pursuant to EO #13848 on Foreign Interference in the election giving him full emergency powers.
 - o **POTUS already declared a national emergency in 2018** due to the threat of foreign interference in our elections when he signed EO #13848.
 - o Under that National Emergency he has all the authority needed to:
 - Secure and analyze the voting machines in all the contested States
 - Appoint an Election Fraud Task Force immediately
 - Appoint a Special Counsel or Principle Deputy Attorney General to lead this effort
 - Utilize National Emergency Funds

- The President signed this EO based on the threats outlined in the 2017 Intelligence Community Assessment. Subsequently, per the 2019 Senate Select Committee on Intelligence Report, the foreign interference threat has only grown significantly worse, creating potentially grave harm to the United States election systems and U.S. National Security.

- **Republican Leaders—CALL TO ACTION**
 - o DEMAND complete and total transparency from the Nov. 3rd election (Stand our ground against the theft of this U.S. Election)
 - o ENCOURAGE the President to use his full authorities under the National Emergency Act, and immediately appoint a Principle Deputy Attorney General and task force to investigate.
 - o DEVELOP a coordinated and daily communications plan to broadcast to all constituents and to the media.
 - o ANNOUNCE your promise to reject the fraudulent electors publicly.
 - o DEMAND that POTUS, using his authorities, immediately secure, inspect and assess electronic voting systems in multiple states (and multiple counties).
 - o REQUEST POTUS speak to the American public NOW and then continue leveraging his voice throughout the remainder of the Congressional period up to 6 JAN and beyond.

Bottom Line: The American people are facing a crisis in confidence and a crucible moment in United States history and there must be a renewed faith instilled back into the confidence of every America Citizen.

Congress MUST NEVER certify a fraudulent election.
